Dear Sir or Madam,

The board of managers of the General Partner (the "**Board**") wishes to draw your attention to an identity misuse of which the General Partner is a victim.

An entity pretending to be named "**Invision Capital Partners**" (the "**Entity**"), which allegedly offers investment services, pretends to be:

- established at 412F route d'Esch, L-2086 Luxembourg (the "**Luxembourg Address**") and at 26 Finsbury Square, London EC2A 1DS,
- and regulated by the *Commission de Surveillance du Secteur Financier*, the Luxembourg financial supervisory authority (the "**CSSF**").

On its website www.invisioncapitalpartners.com (the "**Entity Website**") the Entity provides that:

- "*Invision Capital Partners is authorised and regulated by the Commission de Surveillance du Secteur Financier, CSSF No: A00002621*" (the "**CSSF Number**")
- it has a registered office in Luxembourg at the above mentioned Luxembourg Address.

We would like to stress that although both the Luxembourg Address, as well as the CSSF Number are those of the General Partner, the Entity, the Entity Website and the "information", links and contacts provided therein are not in any way whatsoever connected to either the General Partner and/or the Fund and/or the group of companies to which they belong.

This has also been made public by the CSSF, which has published a warning on its website on 16 August 2021¹ whereby it informs the public of the fact that the Entity:

- (i) presenting itself on the Entity Website under the name Invision Capital Partners **is not regulated by the CSSF,**
- (ii) **has not been granted any authorisation** to provide investment services or other financial services in or from Luxembourg
- (iii) **has no link with the General Partner**, which is a duly registered alternative investment fund manager within the meaning of the Law of 12 July 2013.

Offering investment services without any granted authorization from the CSSF is not only illegal, but also a criminal offence under Luxembourg law.

In view of the forgoing it seems that the Entity's false statements (i) to be authorised and regulated by the CSSF under No: A00002621 and (ii) to have a registered office in Luxembourg at the above mentioned Luxembourg Address, as well as the misuse of the General Partner's identity, are intended to fraudulently mislead investors and potential investors .

As the Entity is operating outside the law with fictitious means, investors have to be very cautious.

As we believe the Entity to be unregulated and operating illegally, and as the Entity has no connection whatsoever to the General Partner, the Fund, the Fund's investment advisers, Invision AG and Invision Beteiligungsberatung GmbH, or any other Invision fund, investors are very strongly advised not to contact or otherwise deal with the Entity or its agents or representatives.

It should be noted that the Entity also holds itself out as operating from an address in London and the General Partner will shortly notify the Financial Conduct Authority in the UK of this matter for its information.
